Testing to detect type 2 diabetes and prediabetes in asymptomatic people should be considered in adults of any age who are overweight or obese (BMI  $\geq 25$  kg/m<sup>2</sup>) and who have one or more additional risk factors for diabetes (see Table 4 of the “ Standards of Medical Care in Diabetes—2013 ” ). In those without these risk factors, testing should begin at age 45 years.

DOJ Responsibility - ADA Regulations
