In Makerere, all applicants wishing to be admitted to the Bachelor of Laws programme are required to sit and pass the pre-entry exams. The pre-entry examinations cover areas such as reading and comprehension skills; language skills; numerical skills and logic; general knowledge and analytical writing skills. Out of those who have passed, 305 were directly from A'level (direct entry) , 26 were on degree entry, 15 were on diploma entry while 6 were on Mature age entry.
